a tributary of Mud Slough (Rickreall Creek) for the purpose of stock for Tract 1 and stock drinking directly from the source and is limited not\* and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Polk County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 17, at page 90; that the priority of the right thereby confirmed dates from 1850

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.005 cubic feet per second for Tract 1 and shall be further 1 mited to the provisions of Finding No. 34 of said Decree for Tract 2.

The point of diversion is located in the NWz SEz, as projected within G. Basket D.L.C. 43, Section 19, Township 7 South, Range 4 West, W.M. (diversion point located below) A description of the place of use under the right, and to which such right is appurtenant, is as follows:
