and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Polk

County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume

17, at page

90; that the priority of the right thereby confirmed dates from

1859

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.035 cubic foot per second, being 0.025 cubic foot per second for irrigation (Tract 1); 0.005 cubic foot per second for domestic (Tract 2); 0.005 cubic foot per second for stock (Tract 3); and shall be further limited to the provisions of Finding No. 34 of said Decree for Tract 4.

The point of diversion is located in the NEL NWL, as projected within J. Allen D.L.C. 42, Section 22, Township 7 South, Range 4 West, W.M. Diversion point is located 520 feet south and 900 feet west from the NL corner Section 22.
