CERTIFICATE OF WATER RIGHT

This Is to Certify, That Laverne A. and Janet E. Perry

of Route 2, Box 269-C, Dallas ,State of Oregon ,has a right to the use of the waters of Ellendale Creek

a tributary of Rickreall Creek for the purpose of irrigation of 3.1 acres and stock and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Polk County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 17, at page 90; that the priority of the right thereby confirmed dates from January 1, 1909

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.044 cubic foot per second, being 0.039 cubic foot per second for irrigation and 0.005 cubic foot per second for stock.

The point of diversion is located in the SWz SEz, as projected within E. Hallock D.L.C. 43, Section 25, Township 7 South, Range 6 West, W.M. (diversion point located below) A description of the place of use under the right, and to which such right is appurtenant, is as follows:

stock and 3.1 acres SEt SEt as projected within E. Hallock D.L.C. 43
Section 25

Township 7 South, Range 6 West, W.M.

Being within the tract of land described as follows: Beginning at an iron pipe on the north line of the county road at a point 887.21 feet north and 814.77 feet west from the southeast corner of Section 25, T. 7 S., R. 6 W., W.M.; running thence along the arc of a 746.25 foot radius curve to the left (the long chord of which bears S. 65° 49½' W. 190.65 feet) to an iron pipe; thence S. 58° 29' W. 488.3 feet to an iron pipe; thence along the arc of a 848.57 foot radius curve to the left (the long chord of which bears S. 50° 03' W. 248.9 feet) to an iron pipe; thence N. 58° 15 3/4' W. 876.0 feet to an iron pipe; thence N. 4° 3½' E. 339.06 feet to an iron pipe; thence S. 71° 52' E. 907.15 feet to an iron pipe from which a 28" oak bears N. 71° 52' W. 16.2 feet; thence N. 48° 36½' E. 549.96 feet to an iron pipe; thence S. 30° 26' E. 449.04 feet to the place of beginning.

Diversion point located: 500 feet north and 2,230 feet west from SE corner Section 25

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
