CERTIFICATE OF WATER RIGHT

This Is to Certify, That Irene L. Rowland

of Route 1, Box 180, Rickreall, State of Oregon, has a right to the use of the waters of Mud Slough for Tract 1; unnamed tributary of Mud Slough for Tract 2; unnamed stream for Tract 3; and Goodwin Branch for Tract 4 a tributary of Mud Slough (Rickreall Creek) for the purpose of stock drinking directly from the sources and is limited not to exceed 200 head and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Polk County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 17, at page 90; that the priority of the right thereby confirmed dates from 1880

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall ~~not exceed~~ be further limited to the provisions of Finding No. 34 of said Decree.
