This Is to Certify, That HARDERT & DOWNING

of Route 2, Box 391, Eugene , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Wells #4 and #5

a tributary of Willamette River

for the purpose of

supplemental irrigation of 179.4 acres
under Permit No. G-3614 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from March 8, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.05 cubic feet per second, being 0.75 cubic foot per second from Well #4 and 0.30 cubic foot per second from Well #5.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE% NW% as projected within Lafferty DLC 46, Section 14; NW% NE% as projected within Dows DLC 45, Section 15, T. 14 S., R. 5 W., W. M. Wells located: #4 - 760 feet South and 1850 feet East; #5 - 11%0 feet South and 1560 feet West from NE Corner, Section 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acreor its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

conform to such reasonable rotation system as may be ordered by the proper state officer.
