CERTIFICATE OF WATER RIGHT

This Is to Certify, That ROBERT VANDEHEY

of Route 1, Box 183-B, Banks , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream and reservoir constructed under application number R-44312, permit number R-5125 a tributary of West Fork Dairy Creek for the purpose of irrigation of 1.8 acres and supplemental irrigation of 16.4 acres

under Permit No. 33092 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 15, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second from unnamed stream and 2.0 acre feet from reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 9 (SE $\frac{1}{4}$ SE $\frac{1}{4}$), Section 24, T. 2 N., R. 4 W., W. M., Reservoir - 1870 feet South and 80 feet West; Stream - 2140 feet South and 20 feet West both from E $\frac{1}{4}$ Corner, Section 24.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-5125, and further limited to the use of stored water only on the lands described as supplemental,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
