CERTIFICATE OF WATER RIGHT

This Is to Certify, That John and MARILYN MOSBY

of 526 Mercury Street, Lompoc , State of California , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Jenny Creek

a tributary of Klamath River for the purpose of

irrigation of 141.3 acres under Permit No. of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby March 22, 1955 confirmed dates from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.02 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL SWL, SEL SEL, Section 16; NEL NEL, Section 22, T. 40 S., R. 4 E., W. M., #1 - 1240 feet North and 2990 feet West; #2 - 750 feet North and 1250 feet West, both from SE Corner, Section 16; #3 - 1030 feet South and 630 feet East from NW Corner, Section 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acreor its equivalent of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be still further limited to a diversion of not to exceed 2.02 cubic feet per second

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
