CERTIFICATE OF WATER RIGHT

This Is to Certify, That

MELVIN A. & LENORE M. WALTERS

of Badger Canyon Ranch, Wamic , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Sherar Springs Creek and Badger Creek

a tributary of White River . for the purpose of irrigation of 74.8 acres and supplemental irrigation of 8.9 acres

under Permit No. 30951 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 30, 1965

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.85 cubic feet per second, being 0.65 cubic foot per second from Sherar Springs Creek and 1.2 cubic feet per second from Badger Creek.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEX SWX, Section 35, T. 3 S., R. 12 E.; NWX NEX. Section 2; NEX NEX, Section 3, T. 4 S., R. 12 E., W. M., 1360 feet North and 2010 feet East; 1130 feet North and 520 feet West; 1310 feet North and 3110 feet East. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
