**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That            (MRS.) J. H. KLOPE**

of            **Route 1, Box 32, Riddle**            , State of            **Oregon**            **97469**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Council Creek**

a tributary of            **Cow Creek**            for the purpose of  
**irrigation of 0.5 acre**

under Permit No.            **18582** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from            **November 15, 1948**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.007 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 33, T. 30 S., R. 6 W., W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-seventieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **3 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season from April 1st to October 1st of each year,**

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**0.5 acre SW $\frac{1}{4}$  SW $\frac{1}{4}$   
Section 33  
T. 30 S., R. 6 W., W. M.**

Certificate of water right issued to Mrs. J. H. Klope and recorded at page **19886, Volume 14, State Record of Water Right Certificates**, confirms the right to the use of water for irrigation of **1.0 acre and domestic**. A change in the right to the use of water appurtenant to **0.5 acre and domestic** was approved by order of the State Engineer entered February 1, 1973. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Mrs. J. H. Klope.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
