CERTIFICATE OF WATER RIGHT

This Is to Certify, That DAVID E. and DARLENE M. CHAMBERS

of **Route 2, Box 159-D, Albany**, State of **Oregon**, ⁹⁷³²¹ has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Webers Well**

a tributary of **Willamette River** for the purpose of **irrigation of 15.6 acres**

under Permit No. **G-42** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **September 28, 1955**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.20 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within McClane DLC 70, Section 18, T. 10 S., R. 3 W., W. M. Well located: 19.50 chains South and 16 chains West from N $\frac{1}{4}$ Corner, Section 18.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**5.6 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
5.4 acres NW $\frac{1}{4}$ NW $\frac{1}{4}$
1.0 acre SW $\frac{1}{4}$ NW $\frac{1}{4}$
3.6 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$**

**All as projected within McClane DLC 70
Section 18
T. 10 S., R. 3 W., W. M.**

Certificate of water right issued to George E. and Dorothy M. Weber and recorded at page 28582, Volume 20, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 27.9 acres. Subsequently, the right to the use of water appurtenant to 12.3 acres was canceled by order of the State Engineer entered March 21st, 1973. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to George E. and Dorothy M. Weber.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
