a tributary of South Umpqua River irrigation of 80.0 acres and domestic

for the purpose of

under Permit No. 6647 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 29, 1924

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.0 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW% NW%, Section 23, T. 29 S., R. 4 W., W. M., 830 feet South and 1250 feet East from the NW Corner, Section 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

23.3 acres NEX NWX

8.4 acres NE's NW's 23.2 acres NW's NW's

Both as projected within Stephens DLC 38

8.6 acres NWt NWt

9.6 acres SWt NWt

2.3 acres SE's NW's

Section 23 T. 29 S., R. 4 W., W. M.

Certificate of water right issued to Earl Beebs and Frank Beebs and recorded at page 7918, Volume 8, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 80.0 acres and domentic. A change in the place of use of water for the irrigation of 37.5 acres and point of diversion was approved by order of the State Engineer entered January 5, 1960. This certificate is issued to confirm the change in place of use and point of diversion and the remaining right to the use of water for irrigation and domestic and supersedes the certificate heretofore issued to Earl Beebs and Frank Beebs. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
