CERTIFICATE OF WATER RIGHT

This Is to Certify, That GERALD C. and THERESA A. SMITH

of **Route 3, Box 498, Dundee**, State of **Oregon**, ⁹⁷¹¹⁵ has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **two springs**

a tributary of **Willamette River** for the purpose of **domestic use of one family, irrigation of 0.9 acres, and stock**

under Permit No. **30933** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **September 21, 1965**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.025 cubic foot per second, being 0.005 cubic foot per second for domestic, 0.01 cubic foot per second for irrigation and 0.005 cubic foot per second for stock from east spring and 0.005 cubic foot per second for stock from west spring** or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the **SE $\frac{1}{4}$ SW $\frac{1}{4}$** as projected within Shuck DLC 57, Section 26, T. 3 S., R. 3 W., W. M. Springs located: **1330 feet South and 620 feet East; 1480 feet South and 1220 feet East, both from NE Corner, Handley ***

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,**

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**domestic and 0.9 acre NE $\frac{1}{4}$ SW $\frac{1}{4}$
stock SE $\frac{1}{4}$ SW $\frac{1}{4}$
Both as projected within Shuck DLC 57
Section 26
T. 3 S., R. 3 W., W. M.**

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
