CERTIFICATE OF WATER RIGHT

This Is to Certify, That **FRANK H. and VIOLA M. GOULD**

of **Route 1, Box 599, Bandon**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Crooked Creek**

a tributary of **Pacific Ocean** for the purpose of irrigation of **7.4 acres**

under Permit No. **26951** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **August 9, 1960 for 0.10 cubic foot per second**
September 6, 1960 for 0.64 cubic foot per second

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.74 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 7, T. 29 S., R. 14 W., W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year. If for irrigation of cranberries, this appropriation shall be limited to **0.10** of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **0.75 acre foot** for each acre irrigated in any 30-day period and shall be still further limited to a diversion of not to exceed **3 acre feet per acre during the irrigation season of each year,** and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**4.0 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
3.4 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
Section 18
T. 29 S., R. 14 W., W. M.**

This certificate is issued to confirm a change in point of diversion approved by an order of the State Engineer entered April 21, 1971, and supersedes certificate of water right heretofore issued to Frank H. and Viola M. Gould and recorded at page 31942, Volume 23, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
