CERTIFICATE OF WATER RIGHT

This Is to Certify, That WALLACE CAMPBELL and ELMER A. JOHNSON

of Mt. Vernon, State of Oregon, has a right to the use of the waters of John Day River

a tributary of Columbia River for the purpose of irrigation of 58.4 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Grant County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 15, at page 461; that the priority of the right thereby confirmed dates from 1881 - Tract #1 1887 - Tract #2

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 cubic foot per second per acre irrigated from April 1 to September 30; further limited to one acre foot per acre per calendar month to July 1 and 3/4 acre foot per acre thereafter; total five acre feet per acre for season, measured at point of diversion.

The point of diversion is located in the Tract #1 - SW 1/4 SW 1/4, Section 21, South 27 deg. 30' East 1817 feet from the W 1/4 Corner, Section 21; Tract #2 - NW 1/4 NE 1/4, Section 27, * A description of the place of use under the right, and to which such right is appurtenant, is as follows:

13.6 acres SW 1/4 NE 1/4
12.5 acres SE 1/4 NE 1/4

Tract #2

8.8 acres SW 1/4 NE 1/4
7.5 acres SE 1/4 NE 1/4

8.5 acres SE 1/4 NW 1/4

This certificate is issued to confirm changes in points of diversion approved by orders of the State Engineer entered April 10, 1945, March 26, 1963, and April 22, 1966 and supersedes certificate of water right heretofore issued to Victor E. and Adel E. Mosier and recorded at page 25593, Volume 17, State Record of Water Right Certificates.

* 50 feet South and 3380 feet East from the NW Corner, Section 27, T. 13 S., R. 29 E., W. M.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
