CERTIFICATE OF WATER RIGHT

This Is to Certify, That w. & E. MILLER RAPICHES, INC.

of Kimberly , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Fork John Day River

a tributary of John Day River (Columbia River) irrigation of 111.05 acres

for the purpose of

under Permit No. 3854 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 12, 1918

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.39 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW\$ SE\$, Section 3, NW\$ NW\$, Section 9, T. 9 S., R. 27 E., W. M., North 49 degrees East, 3814 feet from the SW Corner, Section 3, 1550 feet South and 470 feet West from the NE Corner, SW\$ SW\$, Section 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is

Certificate of water right issued to Otis Cork and J. D. Boyer and recorded at page 5383, Volume 6, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 119.65 acres. A change in the point of diversion for the irrigation of 26.0 acres was approved by order of the State Engineer entered December 18, 1959. Subsequently, the right appurtenant to 8.6 acres was cancaled by order of the State Engineer entered May 9, 1969. This certificate is issued to confirm the remaining right and change in point of diversion for the irrigation and supersedes the certificate heretofore issued to Otis Cork and J. D. Boyer.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
