CERTIFICATE OF WATER RIGHT

This Is to Certify, That DONALD S. and RUTH B. HOWELL
of **Route 2, Box 783 B, Coos Bay**, State of **Oregon**, has made proof
to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of
two springs and an unnamed stream

a tributary of **Joe Ney Slough** for the purpose of
domestic use of one family and irrigation of 0.9 acre

under Permit No. **33993** of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from **November 26, 1968**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
0.02 cubic foot per second being 0.005 cubic foot per second from each spring
for domestic and 0.01 cubic foot per second from unnamed stream for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the **Lot 3 (NE $\frac{1}{4}$ NW $\frac{1}{4}$); SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 12, T. 26 S.,
R. 14 W., W. M. Springs - 20 feet North and 320 feet West; 40 feet North and
470 feet West; Unnamed stream - 20 feet South and 870 feet West; all from SE ***

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second
per acre, or its equivalent for each acre irrigated and shall be further limited
to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre for each acre irrigated**
during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is
appurtenant, is as follows:

**Domestic and 0.8 acre Lot 3 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)
0.1 acre SE $\frac{1}{4}$ NW $\frac{1}{4}$
Section 12
T. 26 S., R. 14 W., W. M.**

* Corner, Lot 3 (NE $\frac{1}{4}$ NW $\frac{1}{4}$), Section 12.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
