CERTIFICATE OF WATER RIGHT

This Is to Certify, That **RAYMOND H. SMITH**

of **P. O. Box 597, Bandon**, State of **Oregon**, has made proof to the satisfaction of the **STATE ENGINEER** of Oregon, of a right to the use of the waters of **Simpson Creek and reservoir constructed under application number R-44978, permit number R-5309**

a tributary of _____ for the purpose of **supplemental irrigation, frost protection and cranberry harvesting of 6.2 acres**

under Permit No. **33619** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **May 24, 1968**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.93 cubic foot per second and 1.5 acre feet stored water, being 0.93 cubic foot per second for frost control and 0.31 cubic foot per second for cranberry harvesting from Simpson Creek and 1.5 acre feet stored water only for supplemental irrigation *** or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the **Creek: NE $\frac{1}{4}$ SE $\frac{1}{4}$, Reservoir: SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 20, T. 28 S., R. 14 W., W. M.; Creek, 1670 feet North and 250 feet East, Reservoir, 700 feet North and 250 feet East from SW Corner, SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 20.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to _____ of one cubic foot per second per acre, if for irrigation, this appropriation shall be limited to a diversion of **3 acre feet for each acre irrigated during the irrigation season of each year for cranberries. If for the irrigation of any other crop this appropriation shall be limited to a diversion of 2 $\frac{1}{2}$ acre feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein**

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
