CERTIFICATE OF WATER RIGHT

This Is to Certify, That **JOHN & HENRY ISENHART &
ONA & CLATTIE SMITH** **97450**

of **Langlois**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed slough and Coquille River

a tributary of **Pacific Ocean** for the purpose of irrigation of 82.8 acres, domestic use of one family, and stock

under Permit No. **29458** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **March 18, 1964**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.045 cubic feet per second, being 1.03 cubic feet per second from unnamed slough for irrigation and 0.005 cubic foot per second for domestic and 0.01 cubic foot per second for stock from Coquille River

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the **Lot 1 (NW $\frac{1}{4}$ NW $\frac{1}{4}$), Lot 2 (SW $\frac{1}{4}$ NW $\frac{1}{4}$), Section 18, T. 28 S., R. 12 W., NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 13, T. 28 S., R. 13 W., W. M., #1 - 1230 feet South and 570 feet East, #2 - 1240 feet South and 1270 feet West, #3 - 1490 feet ***

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
