of Old Highway 99, Box 66, Glendale , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mynatt Creek and Brady Pond constructed under Application number R-47413, Permit number R-5714
a tributary of Cow Greek for the purpose of

irrigation of 2.2 acres and supplemental irrigation of 24.2 acres

under Permit No. 35605 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 3, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second from Mynatt Creek and 9.65 acre feet from Brady Pond

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SEK SEK, as projected within Mynatti DLC 37, Section 15, T. 32 S., R. 5 W., W. M., Reservoir - 1520 feet South and 730 feet West, Creek - 1840 feet South and 1080 feet West both from EK Corner, Section 15.

The amount of water used for irrigation, together with the amount secured under any other

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-seventieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3½ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under Permit number R-5714, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and further limited to the use of stored water only on lands described as supplemental, and shall not reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
