## CERTIFICATE OF WATER RIGHT

the waters of Salmon Creek (for all dates) Slough between Secs. 35 and 36, Waggie Creek and Spring Creek for last two dates only.

for the purpose of the irrigation of 630 acres of land and mining

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 5, at page 291; that the priority of the right thereby confirmed dates from 1864 for 75 acres; 1867 for 365 acres and 1898 for 190 acres.

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 of one cubic foot per second per acre; and shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows: 40 acres in the Southwest quarter of Southwest quarter; 40 acres in the Southeast quarter of Southwest quarter; 35 acres in the Southwest quarter of Southeast quarter and 35 acres in the Southeast quarter of Southeast quarter of Section Twenty-six: 40 acres in the Northeast quarter of Northeast quarter: 40 acres in the Northwest quarter of Northeast quarter; 40 acres in the Southwest quarter of Northeast quarter; 40 acres in the Southeast quarter of Northeast quarter; 40 acres in the Northeast quarter of Northwest quarter; 40 acres in the Northwest quarter of Northwest quarter; 40 acres in the Southwest quarter of Northwest quarter; 40 acres in the Southeast quarter of Northwest quarter; 40 acres in the Northeast quarter of Southeast quarter; 40 acres in the Northwest quarter of Southeast quarter; 40 acres in the Southwest quarter of Southeast quarter and 40 acres in the Southeast quarter of Southeast quarter of Section Thirty-five, Township Eight South, Range Thirty-nine East of Willamette Meridian, in Baker County, Oregon.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
