under Permit No. 13752 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 19. 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.325 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SW1 SE1, as projected within Carlyle DLC 64,

SW2 SE1, as projected within Toney DLC 67, Section 24, NE1 NE2, NW2 NE1, SE1 NE2,

all as projected within Toney DLC 67, Section 25, T. 5 S., R. 6 W. W. H. SW1 NW1,\*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year.
