CERTIFICATE OF WATER RIGHT

This Is to Certify, That MURL LAIRD

97458

of **Sitkum Route, Box 141-A, Myrtle Point**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **East Fork Coquille River and a spring**

a tributary of **Coquille River** for the purpose of **irrigation of 72.9 acres, crop spraying, stock, and domestic use of two families**

under Permit No. **29296** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **January 29, 1964**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.935 cubic foot per second, being 0.91 cubic foot per second for irrigation from East Fork Coquille River, 0.01 cubic foot per second for stock, 0.01 cubic foot per second for domestic use, and 0.005 cubic foot per second for crop spraying from *** or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the **SE $\frac{1}{4}$ NE $\frac{1}{4}$, SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 10, T. 28 S., R. 11 W., W. M., 3040 feet North and 1010 feet West, 3210 feet North and 1230 feet West, 740 feet North and 1030 feet West, all from SE Corner, Section 10.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,**

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**Crop Spraying, Domestic, and 0.2 acre SW $\frac{1}{4}$ NE $\frac{1}{4}$
Crop Spraying SE $\frac{1}{4}$ NE $\frac{1}{4}$
Crop Spraying, Domestic, Stock, and 11.5 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$
Crop Spraying and 18.2 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
29.8 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$
Section 10
13.2 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 11
