**CERTIFICATE OF WATER RIGHT**

**This Is to Certify**, That **MARTIN VACHTER, Jr.**

of **Route 1, Box 204, Gerva's**, State of **Oregon**, **97026**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of **Pudding River** for the purpose of irrigation of **47.8 acres**

under Permit No. **G-4526** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **March 4, 1969**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.63 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **Lot 5 (SW $\frac{1}{4}$  SW $\frac{1}{4}$ ), Section 30, T. 5 S., R. 1 W., W. M., 280 feet North and 1060 feet East from SW Corner, Section 30.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$  acre feet per acre** for each acre irrigated during the irrigation season of each year; and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others,

and shall conform to such reasonable rotation system or may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**26.8 acres Lot 5 (SW $\frac{1}{4}$  SW $\frac{1}{4}$ )  
6.0 acres Lot 5 (SE $\frac{1}{4}$  SW $\frac{1}{4}$ )  
Section 30**

**12.8 acres Lot 3 (NE $\frac{1}{4}$  NW $\frac{1}{4}$ )  
2.2 acres Lot 4 (NW $\frac{1}{4}$  NW $\frac{1}{4}$ )  
Section 31  
T. 5 S., R. 1 W., W. M.**

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
