CERTIFICATE OF WATER RIGHT

This Is to Certify, That **CLAUDIO BUSTAMANTE** 97137
of **Star Route, Box 10, Saint Paul**, State of **Oregon**, has made proof
to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of
a well

a tributary of **Champoeg Creek** for the purpose of
irrigation of 38.0 acres

under Permit No. **G-4200** of the State Engineer, and that said right to the use of said water,
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from **June 24, 1968**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
0.48 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the **SE $\frac{1}{4}$ SW $\frac{1}{4}$** , as projected within **Bertrand DLC 89**,
Section 30, T. 4 S., R. 2 W., W. M., 4060 feet South and 2780 feet West from NE Corner,
Lambert DLC 63.

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second
per acre, or its equivalent for each acre irrigated and shall be further limited to
a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during
the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is
appurtenant, is as follows:

0.8 acre NE $\frac{1}{4}$ SW $\frac{1}{4}$
25.2 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
8.0 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$
All as projected within Bertrand DLC 89
Section 30
T. 4 S., R. 2 W., W. M.

3.2 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$
0.8 acre SE $\frac{1}{4}$ SE $\frac{1}{4}$
Both as projected within Bertrand DLC 66
Section 25
T. 4 S., R. 3 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
