CERTIFICATE OF WATER RIGHT

This Is to Certify, That Raymond H. and/or Millie L. Adams

of Route 3, Box 100, Dallas, State of Oregon, has a right to the use of the waters of Middle Fork Ash Creek for Tract 1; unnamed stream for Tract 2; unnamed stream for Tract 3; spring for Tract 4 a tributary of Ash Creek for the purpose of stock watering directly from the sources and is limited not to exceed 160 head and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Polk County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 17, at page 216; that the priority of the right thereby confirmed dates from 1850

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed be further limited to the provisions of Finding No. 30 of said Decree.

Being within the tracts of land described as follows:

Beginning at a point 13.10 chains West from the Northeast corner of the Samuel L. Campbell Donation Land Claim Not. No. 2273, Claim No. 64 in Section 11, Township 8 South, Range 5 West of the Willamette Meridian in the County of Polk and State of Oregon; and running thence west 12.85 chains along the center of the H. M. Ebbert road to a rock; thence South 1° East 13.51 chains along the center of said road; thence South 8° East 15.19 chains along the center of said road; thence South 71° 30' West 18.66 chains along the center of said road; thence South 13° West 5.30 chains along the center of said road to a rock; thence East 23.85 chains; thence North 12.36 chains to a 3 inch round oak stake from which an 8 inch oak bears South 43° West 58 links and a 12 inch ash bears North 62° 20' West 309 links; thence East 5.57 chains to a 3 inch ash stake from which an 8 inch oak bears North 38° 30' East 83 links and a 14 inch oak bears North 69° 30' West 118 links and thence North 27.26 chains to the place of beginning, which point is marked by a 3 inch oak stake, containing 54 acres, more or less and being a part of said Samuel L. Campbell DLC.

Beginning at the Southwest corner of the Benjamin Whiteaker and wife Donation Land Claim in Township 8 South, Range 5 West of the Willamette Meridian, in Polk County, Oregon, running thence West 22.10 chains; thence North 12.26 chains; thence East 3.10 chains; thence North 12.50 chains; thence East 5.90 chains; thence North 27.26 chains; thence East 13.10 chains to the Northeast corner of the Samuel L. Campbell Donation Land Claim; thence South 6.36 chains; thence East 19.62 chains; thence South 8.81 chains; thence West 19.62 chains; thence South 36.84 chains to the place of beginning, containing 103.80 acres, more or less.
