that the amount of water to which such right is entitled, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.006 cubic foot per second, being 0.005 cubic foot per second from a spring for domestic; 0.001 cubic foot per second from Waymire Creek for irrigation; and shall be further limited to the provisions of Finding No. 61 of said Decree.

The point of diversion is located in the NE'z SW'z, Lot 5 (SE'z SW'z), Section 15, T. 8 S., P. 6 W., W.M.

Diversion point located: 1640 feet North and 1090 feet East; Spring located: 540 feet North and 1180 feet East; both from the southeast corner Kramer DLC 49.
