CERTIFICATE OF WATER RIGHT

This Is to Certify, That Frank O. and Beulah V. Davis

of Route 2, Box 86, Monmouth, State of Oregon, has a right to the use of the waters of a spring for Tract 1, three springs and an unnamed stream for Tract 2 a tributary of Luckiamute River for the purpose of domestic use of one family including the irrigation of 0.2 acre lawn and garden* and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Polk County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 17, at page 217; that the priority of the right thereby confirmed dates from 1852

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second from a spring for domestic use and shall be further limited to the provisions of Finding No. 61 of said Decree.

The point of diversion is located in the Lot 6 (SE½ SE½) Section 4, T. 10 S., R. 6 W., W.M. Spring located: 380 feet North and 250 feet East from the Southwest corner, Lot 6 (SE½ SE½).

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

Being within the tract of land described as follows:
Beginning at the most Westerly Southwest corner of the R. J. Grant Donation Land Claim in Township 10 South, Range 6 West of the Willamette Meridian in Polk County, Oregon, and running thence North 71 degrees East 5.0 chains; thence North 85 degrees East 25.03 chains; thence North 9 degrees West 22.21 chains; thence North 23 degrees West 14.40 chains; thence South 84 degrees West 27.60 chains to the West line of the said Grant Donation Land Claim; thence South 5 degrees East along the West line of said Grant Donation Land Claim 39.80 chains to the place of beginning.

*(Tract 1); stock drinking directly from three springs and one unnamed stream and is limited not to exceed 25 head (Tract 2)

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
