CERTIFICATE OF WATER RIGHT

This Is to Certify, That Norval Embree

of Route 2, Box 185, Dallas, State of Oregon, has a right to the use of the waters of a spring (Tracts 1 and 2), two springs (Tract 3)

a tributary of Little Luckiamute River for the purpose of domestic use of one family including the irrigation of 0.5 acre lawn and garden* and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Polk County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 17, at page 217; that the priority of the right thereby confirmed dates from 1880

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.015 cubic foot per second being 0.01 cubic foot per second for domestic and 0.005 cubic foot per second for stock from a spring; and shall be further limited to the provisions of Finding No. 61 of said Decree.

The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Burns DLC 56, Section 35, T. 8 S., R. 6 W., W.M.

Spring located: 480 feet North and 1180 feet East from Southwest corner Burns DLC 56.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

Being within the tract of land described as follows: Beginning at the Southwest corner of the William Burns Donation Land Claim No. 56, Sec. 35, Township 8 South, Range 6 West of the Willamette Meridian, in Polk County, Oregon; thence South 58° 30' East 18.87 chains; thence North 28° East 26.45 chains to the South line of the County Road No. 865; thence Northwesterly along the South Line of said right of way to a point North 28° 15' East of the place of beginning; thence South 28° 15' West to the place of beginning.

*(Tract 1), stock use (Tract 2), stock drinking directly from two springs and is limited not to exceed 15 head (Tract 3)

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
