## CERTIFICATE OF WATER RIGHT

**This Is to Certify,** That Henry R. and Joan G. Kaiser

of Route 2, Box 97, Monmouth, State of Oregon, has a right to the use of the waters of a spring and stream for Tract 1, three springs for Tract 2, an unnamed stream for Tract 3, and Ritner Creek for Tract 4 a tributary of Luckiamute River (Willamette River) for the purpose of domestic use of one family including the irrigation of 0.5 acre lawn and garden\* and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Polk County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 17, at page 217; that the priority of the right thereby confirmed dates from 1895

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second for domestic from a spring and stream and shall be further limited to the provisions of Finding No. 61 of said Decree.

The point of diversion is located in the SW $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within S. Ritner DLC 59, Section 5, T. 10 S., R. 6 W., W. M. Spring located: 2300 feet South and 1100 feet East; Diversion point located: 1330 feet South and 1240 feet East; both from Northwest corner S. Ritner DLC 59.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

\*(Tract 1); stock drinking directly from the sources and is limited not to exceed 129 head (Tracts 2, 3, and 4)

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
