County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 17, at page 217; that the priority of the right thereby confirmed dates from 1898

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed.01 cubic foot per second for domestic and shall be further limited to the provisions of Finding No. 61 of said Decree.

The point of diversion is located in the NE's SE's, Section 6, T. 10 S., R. 6 W., W.M.

Two springs located: 430 feet North and 600 feet West; 500 feet North and 660 feet West; both from the Southeast corner, NE's SE's, Section 6.
