and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for

County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume
17, at page
217; that the priority of the right thereby
confirmed dates from
1906

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.025 cubic foot per second being 0.005 cubic foot per second from spring for domestic, 0.02 cubic foot per second from Mitchell Creek for irrigation and shall be further limited to the provisions of Finding No. 61 of said Decree.

The point of diversion is located in the Lot 1 (NW2 NW2) Section 15, T. 8 S., R. 6 W., W.M. Diversion point located: 630 feet South and 560 feet East; Spring located: 100 feet South and 440 feet East; both from Northwest corner Section 15.
