CERTIFICATE OF WATER RIGHT

This Is to Certify, That Ethel E. Raw

of 3460 Polk N.W., Corvallis, State of Oregon, has a right to the use of the waters of a spring for Tract 1; four springs for Tract 2; Luckiamute River for Tract 3 a tributary of Willamette River for the purpose of stock use (Tract 1) and stock drinking directly from the sources and is limited* and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Polk County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 17, at page 217; that the priority of the right thereby confirmed dates from 1880

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.005 cubic foot per second from a spring for stock and shall be further limited to the provisions of Finding No. 61 of said Decree.

The point of diversion is located in the Lot 7 (NW $\frac{1}{2}$ NW $\frac{1}{2}$) Section 16, T. 10 S., R. 6 W., W.M.

Spring located: 300 feet South and 580 feet East from Northwest corner, Section 16.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
