CERTIFICATE OF WATER RIGHT

This Is to Certify, That Fred and Goldie Sellers

of 541 Riverview Drive, N.W., Salem, State of Oregon, has a right to the use of the waters of a spring for Tract 1, Mitchell Creek for Tract 2, and Waymire Creek for Tract 3 a tributary of Little Luckiamute River (Luckiamute River) for the purpose of domestic use of one family (Tract 1); stock drinking directly from Mitchell and* and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Polk County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 17, at page 217; that the priority of the right thereby confirmed dates from 1881

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.005 cubic foot per second from a spring for domestic and shall be further limited to the provisions of Finding No. 61 of said Decree.

The point of diversion is located in the Lot 1 (NW $\frac{1}{2}$ NW $\frac{1}{2}$) Section 15, T. 8 S., R. 6 W., W.M. Spring located: 270 feet South and 550 feet East from Northeast corner Kramer DLC 49.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

Being within the tract of land described as follows: Beginning at the Northeast corner of the Donation Land Claim of John A. Kramer, Not. No. 5279, Claim No. 49, in Township 8 South, Range six West of the Willamette Meridian, in Polk County, Oregon, and running thence South 22.60 chains; thence East 17.87 chains to the center of the Dallas-Falls City County road; thence Northeasterly with the center of said road to a point which is S. 83 deg. 30' East 27.75 chains from the place of beginning; thence North 83 deg. 30' West 26.75 chains to the place of beginning, containing 47.27 acres more or less.

*Waymire Creeks and is limited not to exceed 10 head (Tracts 2 and 3)

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
