under Per nit No. G-3683 of the State Engineer, and that said right to the use of said waters has been 1 erfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 10, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.71 cubic foot per second, being 0.19 cubic foot per second from Well #1, 0.14 cubic foot per second from Well #2, 0.19 cubic foot per second from Well #3, and 0.19 cubic foot per second from Well #6

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the #1 - SEX NWX, as projected within Matheny DLC 67,
#3 - SEX NWX, as projected within Kirkwood DLC 64, #2 & #4 - NEX SWX, as projected within Kirkwood DLC 64. Section 29. T. 5 S. R. 3 W. N. M. #1 - 1260 feet North

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second
per acre, or its equivalent for each acre irrigated and shall be further limited to
a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during
the irrigation season of each year, provided further that the right allowed herein
shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
