CERTIFICATE OF WATER RIGHT

This Is to Certify, That **MEDFORD CORPORATION**
of **c/o Ken Pickens** **97501**
P. O. Box 550, Medford, State of **Oregon**, has made proof
to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of
Clarks Creek

a tributary of **Big Butte Creek** for the purpose of
irrigation of 38.7 acres and supplemental irrigation of 80.0 acres

under Permit No. **5971** of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from **July 18, 1923**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
1.48 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the **SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 8, T. 34 S., R. 2 E., W. M.,**

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second
per acre,

and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is
appurtenant, is as follows:

An order of the State Engineer entered November 30, 1970, approves a change in
place of use for the irrigation of 100.0 acres. This certificate is issued to
confirm the remaining right and the change in place of use, and supersedes the
certificate heretofore issued to O. W. Train and recorded at page 10524, State
Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
