that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed three acre feet per acre in any irrigation season, and one-fortieth of one cubic foot per second for each one thousand head of stock and a reasonable amount for domestic purposes.

The point of diversion is located in the NWk SEk, as projected within Rudio DLC 38, Section 3, T. 1 S., R. 14 E., W. M., for domestic and stock; NE% NE%, Lot 1 (SE% NE%), NE% SW%, SE% SW%, both as projected within Rudio DLC 38, Lot 4 (NE% SE%), NE% SE%, NW% SE%, both as projected within Rudio DLC 38, Section 3, T. 1 S., R. 14 E., W. An order of the State Engineer entered May 5, 1964, approved a change in point of diversion for irrigation, domestic, and stock, subsequently, an order of the State Engineer entered December 17, 1973, approved a change in place of use for the irrigation of 2.5 acres. This certificate is issued to confirm the changes in points of diversion and to confirm the remaining right and supersedes the certificate heretofore issued to Nicholas Fax and recorded at page 5630, State Record of Water Right Certificates.
