CERTIFICATE OF WATER RIGHT

This Is to Certify, That **JAMES G. & SHIRLEE D. PERKINS**

of **11404 SW Breyden Court, Portland**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **John Day River**

a tributary of **Columbia River** for the purpose of **supplemental irrigation of 14.2 acres**

under Permit No. **14546** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **August 15, 1940**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.36 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 32, T. 7 S., R. 19 E., W. M., 3380 feet South and 740 feet East from N $\frac{1}{4}$ Corner, Section 32.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-fortieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be limited to a **diversion of not to exceed one acre foot per acre for each acre irrigated during any month and shall be further limited to a total diversion of not to exceed 5 acre feet per acre for each acre irrigated during the irrigation season from April 1st to September 30th of each year.**

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**2.2 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
12.0 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 32
T. 7 S., R. 19 E., W. M.**

This certificate is issued to confirm a change in point of diversion approved by an order of the State Engineer entered September 30, 1968, and to correctly describe the proper acreage, and supersedes certificate of water right heretofore issued to Donald H. McRae and Katherine Dillard and recorded at page 15734, Volume 13, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
