Dayton , State of Oregon , nas made proof to the satisfaction of the STATE ENGINEER of Cregon, of a right to the use of the waters of Palmer Creek and reservoir constructed under Application number R-32100, Permit number R-2116 a tributary of Yamhill River for the purpose of irrigation of 30.4 acres and supplemental irrigation of 30.4 acres

of the State Engineer, and that said right to the use of said waters under Permit No. 25363 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 3, 1958

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cobic foot per second from Palmer Creek and 6.0 acre feet from reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL SWL, as projected within Robinson DLC 52, and Lot 4 (SW SEk), Section 28, T. 4 S., R. 3 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 24 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit number R-2116, and shall be further limited to the use of stored water only on lands described as supplemental,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Primary Palmer Creek 1.4 acres NW NET 20.0 acres SWk NEW 0.2 acre SEt NEX 0.8 acre NEW NWY 8.0 acres SEt NWt All as projected within Chrisman DLC 50

Section 28 T. 4 S., R. 3 W., W. M.

Supplemental Reservoir 3.6 acres NEt SWt 2.4 acres SEk SWk Both as projected within Robinson DLC 52

5.5 acres Lot 3 (NW SE) 1.4 acres NWt SEt

3.5 acres SWk SEk Both as projected within Robinson DLC 52

14.0 acres Lot 4 (SW SE%) Section 28

This certificate is issued to confirm a change in place of use approved by an order of the State Engineer entered April 16, 1969 and to confirm the remaining right approved by an order of the State Engineer entered March 18, 1968, and supersedes certificate of water right heretofore issued to C.
