, State of , has made proof Box 109, Star Route, Saint Paul Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mission Creek and reservoir constructed under Application number R-44515, Permit number R-5248

a tributary of Champoeg Creek irrigation of 46.8 acres

for the purpose of

of the State Engineer, and that said right to the use of said waters under Permit No. 33226 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 7, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.59 cubic foot per second from creek and 48.98 acre feet stored water only from reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 7 (SEt SEt), Section 8, Lot 2 (NWt NWt), Section 20, T. 4 S., R. 2 W., W. M., Dam - South 85 degrees West 380 feet from NW Corner, Pettier DLC 92, Pumps - 1030 feet North and 170 feet West, 890 feet North and \* The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 24 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit number R-5248,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
