## CERTIFICATE OF WATER RIGHT

This Is to Certify, That R. A. CREIGHTON

of P. O. Box 419, Union, State of Oregon, 97883, has a right to the use of the waters of Catherine Creek

a tributary of Grande Ronde River for the purpose of irrigation of 132.4 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 8, at page 1; that the priority of the right thereby confirmed dates from 1867 for Tract No. 2 and 1883 for Tract No. 3

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed three acre feet per acre in any irrigation season, diverted at a rate of not to exceed one-fortieth of a cubic foot per second per acre,

The point of diversion is located in the SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 13, T. 4 S., R. 39 E., W. M., 710 feet North and 400 feet West from SE Corner, Section 13.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
