CERTIFICATE OF WATER RIGHT

This Is to Certify, That R. W. GATES

of **1124 E. Walnut Street, Hillsboro**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Dairy Creek**

a tributary of **Tualatin River** for the purpose of
irrigation of 17.6 acres

under Permit No. **24138** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **March 30, 1956**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.21 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **Lot 3 (SE $\frac{1}{4}$ SW $\frac{1}{4}$)**, Section 26, T. 1 N., R. 3 W., W. M., 10 feet North and 2645 feet West from SE Corner, Section 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre SW $\frac{1}{4}$ SE $\frac{1}{4}$
As projected within **Wooley DLC 49**
2.6 acres Lot 2 (SW $\frac{1}{4}$ SE $\frac{1}{4}$)
11.7 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$
As projected within **Wooley DLC 49**
2.8 acres Lot 1 (SE $\frac{1}{4}$ SE $\frac{1}{4}$)
Section 26
T. 1 N., R. 3 W., W. M.

This certificate is issued to confirm a change in point of diversion approved by an order of the State Engineer entered December 12, 1968, and together with the certificate recorded at page 35927, Volume 27, supersedes certificate of water right heretofore issued to John W. Gates and recorded at page 28749, Volume 20, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
