CERTIFICATE OF WATER RIGHT

This Is to Certify, That **WALTER R. MILLER**

of **1660 Mt. Jefferson Drive, Stayton**, State of **Oregon**, **97383**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **North Santiam River and Detroit Reservoir constructed under Permit No. R-1625** a tributary of **Willamette River** for the purpose of **irrigation of 156.4 acres**

under Permit No. **33676** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **June 14, 1968**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **1.96 cubic feet per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the **Reservoir - SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 7, T. 10 S., R. 5 E., W. M., River - Lot 10 (NW $\frac{1}{4}$ SE $\frac{1}{4}$), Section 35, T. 9 S., R. 2 W., W. M., 5540 feet North and 2850 feet West from SE Corner, Smallman DLC 53.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1625, and is subject to the terms and conditions of contract No. 14-06-100-6299 between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the State Engineer,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
