CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHNSON BROTHERS IRRIGATION DITCH CO.
c/o Geraldine L. Guidry, Sec.

of 27225 Highway 62, Trail, State of Oregon, has a right
to the use of the waters of Elk Creek

a tributary of Rogue River for the purpose of
irrigation of 76.76 acres, domestic and stock
and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Jackson County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume 4, at page 1; that the priority of the right thereby
confirmed dates from 1894;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 1.92 cubic feet per
second.

The point of diversion is located in the SW $\frac{1}{2}$ SW $\frac{1}{2}$, Section 20, Township 33 South, Range
1 East, W.M.

A description of the place of use under the right, and to which such right is appurtenant, is as
follows:

Certificate of water right issued to Norman T. McDonald and recorded at page
36602, Volume 28, State Record of Water Right Certificates confirms the right
to the use of water for irrigation of 77.1 acres. Subsequently, the right to
the use of water appurtenant to 0.34 acre was canceled by order of the State
Engineer entered August 2, 1974. This certificate is issued to confirm the
remaining right to the use of water for irrigation and supersedes the certificate
heretofore issued to Norman T. McDonald.

And said right shall be subject to all other conditions and limitations contained in said decree.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place
of use herein described.
