CERTIFICATE OF WATER RIGHT

This is to Certify, That S. O. CORRELL

of Baker, State of Oregon has a right to the use of

the waters of Sutton Creek, a tributary of Powder River, and Powder River, a tributary of Snake River for the purpose of the irrigation of 313 acres of land

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 6, at page 291; that the priority of the right thereby confirmed dates from 1908 for Tract No. 1; 1880 for Tract No. 2; 1883 for Tract No. 3 and April 24, 1885 for Tract No. 4

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 of one cubic foot per second per acre; and shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract No. 1 from Sutton Creek: 20 acres in the Southwest quarter of Southeast quarter and 30 acres in the Southeast quarter of Southeast quarter of Section Thirty-four and 10 acres in the Southwest quarter of Southwest quarter of Section Thirty-five, Township Nine South, Range Forty: 30 acres in the Northwest quarter of Northwest quarter and 25 acres in the Southwest quarter of Northwest quarter of Section Two and 15 acres in the Northeast quarter of Northeast quarter of Section Three, Township Ten South, Range Forty East of Willamette Meridian, in Baker County, Oregon.

Tract No. 2 from Powder River: 25 acres in the Northwest quarter of Southeast quarter and 40 acres in the Southwest quarter of Northeast quarter of Section Eighteen Township Nine South, Range Forty East of Willamette Meridian, in Baker County, Oregon.

Tract No. 3 from Powder River: 15 acres in the Northwest quarter of Southeast quarter and 23 acres in the Southwest quarter of Southeast quarter of Section Eighteen, Township Nine South, Range Forty East of Willamette Meridian, in Baker County, Oregon.

Tract No. 4 from Powder River: 40 acres in the Southwest quarter of Northeast quarter of Section Thirty-five, Township Eight South, Range Forty and 40 acres in the Northwest quarter of Northeast quarter of Section Ten, Township Nine South, Range Forty All East of Willamette Meridian, in Baker County, Oregon.
