of P. O. Box 121, Payette , State of Idaho , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willow Creek

a tributary of Grande Ronde River irrigation of 136.4 acres

for the purpose of

under Permit No. 27863 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 20, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.74 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW\$ SE\$, Section 9, T. 1 S., R. 39 E., W. M., 2400 feet North and 825 feet East from S\$ Corner, Section 9.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of Lower Grande Ronde River is more that 300 cubic feet per second at USGS Gage No. 3325 and more than 420 cubic feet per second at Oregon-Washington border;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

20.0 acres SW\2 SW\2

20.0 acres SW\ SW\ Section 9

19.2 acres NE\ NW\ 40.0 acres NW\ NW\ 1.6 acres SE\ NW\ 18.2 acres NW\ SW\ 0.9 acre SW\ SW\ Section 16

This certificate is issued to confirm a change in point of diversion approved by an order of the State Engineer entered November 18, 1971, and together with the certificate recorded at page 37990, Volume 30, supersedes certificate of water right heretofore issued to Reed Taylor and recorded at page 34817, Volume 26, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
