CERTIFICATE OF WATER RIGHT

This Is to Certify, That DANIEL DENNIS

of **Route 4, Box 406, Sherwood**, State of **Oregon**, **97140**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Tualatin River**

a tributary of **Willamette River** for the purpose of **irrigation of 30.0 acres**

under Permit No. **20250** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **March 12, 1951**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.38 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **Lot 1 (SE $\frac{1}{4}$ NW $\frac{1}{4}$), Section 18, T. 2 S., R. 1 W., W. M., 860 feet South and 340 feet West from NE Corner, Hicklins DLC 42.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.3 acre SW $\frac{1}{4}$ NE $\frac{1}{4}$
8.3 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
Both as projected within Hicklins DLC 42
5.8 acres Lot 1 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)
0.2 acre NW $\frac{1}{4}$ SW $\frac{1}{4}$
11.4 acres Lot 2 (NE $\frac{1}{4}$ SW $\frac{1}{4}$)
4.0 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
As projected within Hicklins DLC 42
Section 18
T. 2 S., R. 1 W., W. M.

This certificate is issued to confirm a change in point of diversion approved by an order of the State Engineer entered April 23, 1971, and supersedes certificate of water right heretofore issued to Elsner Brothers, and recorded at page 23027, Volume 16, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
