CERTIFICATE OF WATER RIGHT

This Is to Certify, That **ROBERT KAUER, JR.**

of **Route 3, Box 373, Cornelius**, State of **Oregon 97113**, has made proof to the satisfaction of the **STATE ENGINEER** of Oregon, of a right to the use of the waters of **two unnamed streams and reservoir constructed under Application No. R-43940, *** a tributary of **Gumb Creek** for the purpose of **irrigation of 168.7 acres and supplemental irrigation of 31.3 acres** under Permit No. **32363** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **August 14, 1967 for stream No. 1 and reservoir September 22, 1967 for stream No. 2**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **1.87 cubic feet per second, being 1.3 cubic feet per second from stream No. 1 and reservoir and 0.57 cubic foot per second from stream No. 2**

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the **Lot 1 (NE $\frac{1}{4}$ SE $\frac{1}{4}$), NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Brunson DLC 42, Section 22, T. 2 N., R. 3 W., W. M., Reservoir and stream No. 1 - 150 feet South and 1050 feet West, stream No. 2 - 500 feet South and 2600 feet West, both from E $\frac{1}{2}$ Corner, Section 22.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit number R-4961, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,**

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
