that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-fortieth cubic foot per second per acre irrigated from April 1 to September 30; further limited to one acre foot per acre per calendar month to July 1 and three-fourths acre foot per acre thereafter; total five acre feet per acre for season, measured at point of diversion.

This certificate is issued to confirm the remaining right to the use of water for stock and irrigation and supersedes the certificate heretofore issued to Bradford C. Trowbridge.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
