## CERTIFICATE OF WATER RIGHT

This is to Certify, That A. P. DAHLSTROM

of North Powder, State of Oregon has a right to the use of

the waters of 16 Mile Springs, Stevens Pasture Springs in SW $\frac{1}{4}$ NW $\frac{1}{4}$  Section 18, North Prong of Clover Creek and Gussie Creek, tributaries of Powder River for the purpose of the irrigation of 136 acres of land

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Baker County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 6, at page 291; that the priority of the right thereby confirmed dates from 1896 for Tract No. 1; 1887 for Tract No. 2; 1896 for Tract No. 3 and 1887 for Tract No. 4

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 of one cubic foot per second per acre; and shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract No. 1 from 16 Mile Springs: 7 acres in the Southwest quarter of Northeast quarter and 2 acres in the Southeast quarter of Northwest quarter of Section Twenty:

Tract No. 2 from Stevens Pasture Springs SW $\frac{1}{4}$ NW $\frac{1}{4}$  Sec. 18: 3.5 acres in the Southwest quarter of Southeast quarter and 3.5 acres in the Southeast quarter of Southwest quarter of Section Eighteen:

Tract No. 3 from North Prong Clover Creek: 30 acres in the Northwest quarter of Northeast quarter of Section Twenty:

Tract No. 4 from Gussie Creek: 15 acres in the Southeast quarter of Southwest quarter of Section Eighteen: 14 acres in the Northwest quarter of Northeast quarter of Section Nineteen: 38 acres in the Southwest quarter of Northwest quarter and 23 acres in the Northeast quarter of Southwest quarter of Section Twenty:

All of the above lands being in Township Five South, Range Thirty-nine East of Willamette Meridian, in Union County, Oregon.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
