CERTIFICATE OF WATER RIGHT

This Is to Certify, That KIRK BROTHERS

of P. O. Box 6, St. Paul , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mission Creek and reservoir constructed under Application number R-44515, Permit number R-5248

a tributary of Champoeg Creek for the purpose of irrigation of 4.9 acres and supplemental irrigation of 40.9 acres

under Permit No. 33225 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 7, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.57 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 7 (NEX SWX), Section 17, Lot 1 (NWX NWX), Section 20, & Lot 7 (SEX SEX), Section 8, T. 4 S., R. 2 W., W. M., Pumps - 1250 feet South and 1390 feet West, 2920 feet South and 2500 feet West, both from SEX. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-5248, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is ____ appurtenant, is as follows:
